

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MoU) is made and executed on this 9th day of April, 2026.

BETWEEN

Agriculture Training Center, Namkum P.O., Ranchi – 834010, Jharkhand, India, an institution engaged in agricultural training and skill development activities (hereinafter referred to as “**ATC Namkum**”), which expression shall, unless repugnant to the context or meaning thereof, include its successors and permitted assigns.

AND

St. Xavier's (Autonomous) College, Ranchi, Dr.Camil Bulcke Path, Ranchi – 834001, Jharkhand, India, a premier higher educational institution affiliated to Ranchi University (hereinafter referred to as “**SXC Ranchi**”), which expression shall, unless repugnant to the context or meaning thereof, include its successors and permitted assigns.

ATC Namkum and SXC Ranchi shall hereinafter be referred to individually as “**Party**” and collectively as “**Parties.**”

1. PREAMBLE

Recognizing the importance of **academic collaboration, skill development, research, and extension activities**, the Parties hereby agree to establish a cooperative relationship to promote mutual academic interests and strengthen the linkage between **education and practical training in agriculture and allied fields.**

2. OBJECTIVES OF THE MoU

 5. Promote **knowledge exchange between faculty, trainers, and students**.

3. SCOPE OF COLLABORATION

The collaboration between the Parties may include, but is not limited to, the following activities:

1. Organization of **seminars, conferences, workshops, and training programmes**.
 2. Facilitation of **student internships, field visits, and experiential learning**.
 3. **Joint research projects and academic publications**.
 4. Exchange of **faculty members, experts, and resource persons** for academic activities.
 5. Collaboration in **community resource development and extension programmes**.
 6. Sharing and developing of **knowledge resources, technical expertise and best practices**.
 7. Promoting sustainable indigenous methods and practices.
 8. Any other activity mutually agreed upon by both Parties.

4. RESPONSIBILITIES OF THE PARTIES

Responsibilities of Agriculture Training Center, Namkum

- Provide **training facilities and technical expertise** for capacity-building programmes.
- Facilitate **practical exposure and field-based learning opportunities**.
- Support joint activities such as **training sessions, workshops, and extension programmes**.

Responsibilities of St. Xavier's College, Ranchi

- Identify and nominate **students and faculty members** for participation in collaborative activities.
 - Provide **academic coordination and institutional support** for programmes conducted under this MoU.
 - Encourage **research collaboration and student engagement** in field-based learning.

5. FINANCIAL ARRANGEMENTS

This MoU is intended to establish academic cooperation and **does not involve any financial commitment** from either Party. Any financial implications for specific programmes shall be **mutually decided and documented separately**.

6. INTELLECTUAL PROPERTY RIGHTS

Any intellectual property arising from **joint research or collaborative activities** under this MoU shall be **mutually discussed and agreed upon** by both Parties in accordance with applicable regulations.

7. CONFIDENTIALITY

Both Parties agree to maintain **confidentiality of any proprietary or sensitive information** shared during the course of collaboration, unless disclosure is required by law or mutually agreed upon.

8. DURATION AND VALIDITY

This MoU shall remain valid for a period of **three (3) years** from the date of signing and may be **extended or renewed with mutual written consent** of both Parties.

9. TERMINATION

Either Party may terminate this MoU by giving **three (3) months written notice** to the other Party. However, any ongoing activities or projects shall be **completed in a mutually agreeable manner**.

10. AMENDMENTS

Any amendment or modification to this MoU shall be made **only through written consent signed by authorized representatives of both Parties**.
